### **REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002**

Thank you for your 10th request for information under the Freedom of Information (Scotland) Act 2002, received by email on 27th April 2015. Your specific requests and the relevant information held by the National Park Authority are provided below.

**“At the meeting today( if my notes are correct), six Board Members and the Chief Executive declared an interest in owning a residential and/or business property in the Park.**

**Could you let me know whether any of members of the Board or your Chief Executive who made a declaration, own a property in the proposed management zones and, if so, who they are.”**

You will find the requested information summarised below.

At the Special Board Meeting on 27<sup>th</sup> April, six Board Members declared potential interests in the Your Park and/or Live Park items on the agenda. This is because they own property within the Park. These potential interests were declared in relation to item 3 (Your Park) and/or item 4 (Live Park) on the agenda.
