I would like to request the following breakdown of your hardware maintenance and costs relevant to IT:

A list of the models of the physical servers, storage devices, tape libraries, network switches and routers under support contracts.

- 3 IBM X3650 M3 Servers
- 1 IBM 7000 Storage Solution
- 1 IBM TS3200 Tape Library
- 1 Cisco 6500 Switch
- 8 Cisco 3750 Switches
- 2 Cisco 2800 Routers

The cost and duration of said contracts, with start and end dates and service level associated with the equipment.

- The total value of 5 year warranty & NBD support for IBM Storage solution expires in April 2018 £2.245.
- The total value of 5 year warranty & NBD support for IBM servers which expires in April 2018, £2,449.
- All Cisco devices include 2 years NBD support, which expires April 2017 £4.200

Could you also supply the names of the suppliers of the above support services.

All servers and storage are supplied by IBM. Cisco Support is provided by BT.
