**Monitoring Statement** 

#### Introduction

- 1. The Loch Lomond and the Trossachs National Park Local Plan was adopted on 13 December 2011. This monitoring statement assesses the progress made on implementing the plan using a number of key indicators, including a review of policies and proposals contained within the Local Plan. It also sets out how we will continue to monitor the Local Plan's strategy, policies and proposals.
- 2. The report consists of a number of tables which contain information on how the Local Plan has influenced development since its adoption. The information which has informed this report has largely came from the National Park Authority's (NPA) planning application database. Other information sources include the various audits such as the Housing Land Audit, the Employment Land Audit and the Vacant and Derelict Land Survey. There is also reference to various reports which will act as supporting documents to the forthcoming Local Development Plan for the National Park.
- 3. This report should be read in conjunction with the 2015 Action Programme which sets out how the NPA is implementing the Local Plan with partners. This report is available to download on our website <a href="www.ourlivepark.com">www.ourlivepark.com</a>. This report will signpost to other documents which will form the evidence base required for the Proposed Local Development Plan. It will also set out changes which could be made to the way in which success is monitored in the forthcoming Local Development Plan once it is adopted.

#### **Purpose of Monitoring Statement**

- 4. It is important that the policies of the Local Plan are monitored and reviewed in order for the NPA's planning policies to remain fit for purpose and support delivery of the National Park Partnership Plan. The NPA is required to publish a monitoring statement as part of its evidence base to inform the Local Development Plan. It has been prepared under the relevant legislation, including the Planning etc (Scotland) Act 2006, the Town and Country Planning (Development Planning) (Scotland) Regulations 2008 and Planning Circular 6/2013.
- 5. The policies contained within the plan have been assessed against the Development Strategy Policy Outcomes, outlined in Section 6 of the Local Plan which are split into 5 Development Themes:
  - Environment,
  - Housing,
  - Economic Development,
  - Sustainable Tourism and Recreation, and
  - Transport Infrastructure
- 6. There are policies in the Local Plan which are in addition to the development strategy which also required to be monitored. These policies are contained in the Sustainable Communities section of the Local Plan and these have their own desirable outcomes which are illustrated in Table 2 below. For the purpose of this report, the review of these policies is also included.

#### **Review of Current Local Plan**

#### Context

- 7. The Loch Lomond and the Trossachs National Park Local Plan is the first Local Plan the Authority has adopted since it was established in 2002. The Local Plan is used by the Authority to determine planning applications and help attract appropriate investment and new development, influencing decisions on infrastructure provision. This report does not monitor policies contained within the Structure Plans which are still part of the National Park's Development Plan as they will be superseded by the forthcoming Local Development Plan. The Local Plan plays a key role in delivering the four statutory aims of the National Park. The overall vision of the Local Plan is to provide:
- "A robust development and land-use planning framework to 2015 that will deliver high quality, sustainable development in an area of outstanding landscape and environmental quality. New development will contribute to the Park's special qualities, directly supporting the social and economic development of the Park's communities and a growing rural economy, contributing to Scotland's prosperity, improving the range and quality of opportunities to experience the National Park, and enhancing its standing as an international visitor destination."
- 8. Table 1 below is an extract from the Local Plan and shows the development themes and the intended outcomes of policies which will be assessed in this report. Table 2 shows the development themes and intended outcomes of the additional Sustainable Communities policies mentioned earlier in this report.

#### **Summary of Findings**

- 9. The period in which the implementation of the Local Plan is assessed from is 13 December 2011 to 31<sup>st</sup> December 2014. In that time the NPA has determined 859 planning applications. For the purposes of this report, planning permission is deemed to be granted from when a decision notice has been issued. The applications were put into the following categories as mentioned above (Please note that applications can fall into more than one category, for example a housing application can have environmental aspects to be considered):
  - Environment 654 applications
  - Housing 436 applications
  - Economic Development 104 applications
  - Sustainable Tourism and Recreation 195 applications
  - Transport infrastructure 130 applications
  - Sustainable Communities 97 applications

## **Looking forward**

The Proposed Local Development Plan (Proposed Plan) aims to continue a strong emphasis on both protecting and enhancing the National Parks Natural Environment. Draft Planning Guidance will be issued with the Proposed Plan which aims to increase the amount of guidance available for anyone wishing to carry out any development which involves the Historic Environment. The Proposed Plan also introduces Overarching Policies which contain many of the above policies which add extra prominence in the Development Plan.

## **Looking Forward**

Housing remains to be a key policy issue for the Park. Moving forward the Proposed Plan aims to increase flexibility to help reach the target of 75 homes per year and to provide a diverse range of house types, sizes and tenures. Guidance will be published along with the Proposed Plan to provide more information on the type of homes required and how these can be delivered. Future success of the housing policies will be judged against both permissions granted and the completions of homes.

### **Looking forward**

The Action programme will continue to highlight key actions on how the allocated sites have been developed and how the Park will work towards delivering development on sites which remain undeveloped. As highlighted above, the Proposed Plan introduces two Rural Development Framework Areas in which a bespoke approach in West Loch Lomondside and Buchanan South. The Proposed Plan identifies land for new businesses and supports more remote places of work while still directing larger scale development within the Towns and Villages. Success in the forthcoming Proposed Plan will be set against the delivery of more allocated sites and an increase of employment opportunities in the Park.

## **Looking forward**

Growth in tourism whilst retaining the Park's special qualities remains a key priority for the National Park. The Proposed Plan aims to help the National Park continue to offer a high quality authentic experience for visitors. Other National Park Projects such as YOUR Park have been progressing with a view to improving the visitor experience within the Park and meet some of these aims. Success in this area will be judged upon the approval of planning applications. Draft Planning Guidance will also be produced on Visitor Experience to help with developers wishing to enhance the experiences for visitors.

### **Looking forward**

Over the last two years the NPA have been working with local businesses in order to help increase the variety of ways visitors and residents get around the Park. The waterbus was introduced three years ago and has seen an increase in users which has helped it extend the season which it is in use. In particular waterbus operators have seen an increase in people bringing their bike on board which suggests that more people are able to cycle places that they normally couldn't thanks to the service. Fit for purpose transport policies are considered crucial to the sustainable future of the National Park. The NPA also has a scenic routes project in which Planning Policy can play a role in facilitating the needs of this project while having considerations for the National Park aims.

## **Looking Forward**

The NPA continue to be committed to facilitating development which helps make communities more sustainable. Aiding the publication of Community Action Plans and continuing to work with local communities to help produce fit for purpose advice on policies remains a priority for the NPA. More work is required to understand fully the Retail dynamics of the Park in order to understand supply and demand for retail provision. The Proposed Plan includes some changes to the above policies. Some policies including Sustainable Development has been reordered and

placed in the Overarching Policies of the Proposed Local Development Plan which gives the policies prominence, highlighting their importance.
