REQUEST UNDER ENVIRONMENTAL INFORMATION (SCOTLAND) REGULATIONS 2004

I refer to your request for information, received by email on 11th March 2017.

We have applied the exemption under Section 39(2) of the Freedom of Information (Scotland) Act 2002 as we have determined that the information sought in your request is environmental information. We are therefore handling your request under the terms of the Environmental Information (Scotland) Regulations 2004 (EIRs). In this case the public interest in maintaining this exemption and in dealing with the request in line with the requirements of the EIRs outweighs any public interest in disclosing the information under FOISA.

Your specific request and the response from the National Park Authority are provided below.

"Can you please supply the following A shape file that dipicts the boundary of the National Park"

I can therefore advise under R6(1)(b) of the EIRs that this information is already publically available and accessible in the requested format.

"A shape file for each of the Permit Zones"

Shape files for each of the permit zones are attached in Appendix A.

"A shape file for the boundary of each of the Campsites managed by Loch Lomond NP or by a third party on their behalf loch lubnaig, sallochy etc."

The Park Authority owned and /or managed campsites are at Loch Chon, Loch Lubnaig and Inchcailloch. Shape files for the boundary of these campsites are attached in Appendix B.

The site at Sallochy is owned by the Forestry Commission, the Park Authority does not hold boundary details for this site. Accordingly I have to advise under S10(4)(a) of the EIRs that this information is not held.
