1 Summary and Reason for Presentation

1.1 The National Park Authority is required to produce a Development Plan Scheme (DPS) on an annual basis. The previous DPS was agreed by Committee on 3rd December 2012. The DPS sets out the programme for preparing and reviewing our local development plan, and what is likely to be involved at different stages in the process.

2 Recommendation

2.1 That **Members**:

Approve the Development Plan Scheme as set out in Appendix 1 of the report and **Agree** to delegate responsibility to the Head of Planning and Rural Development for making any final minor editorial amendments to the Development Plan Scheme including desktop publishing with the use of drawings, illustrations or diagrams.

3 Background

3.1 The Planning etc (Scotland) Act 2006 introduced reforms to the development plan system and placed the requirement on Planning Authorities to prepare a Local Development Plan. At the time that this requirement came into effect, the National Park Authority had already commenced the preparation of its Local Plan in 2007 and this continued through transitional arrangements. The Local Development Plan, which follows a different process to that of the Local Plan, will replace our Adopted Local Plan and our inherited Approved Structure Plans. The majority of Planning Authorities in Scotland are now at an advanced stage of progressing their new Local Development Plans and the 4 Strategic Development Plans.

- 3.1 The National Park Authority is also required to ensure that its Adopted Local Plan is kept under review. It is critical that the policies that are used to determine planning applications are updated where necessary to reflect changing circumstances, strategy or policies such as, the Partnership Plan and the emerging new Scottish Planning Policy and National Planning Framework. By doing this it ensures that the planning system is responsive and proactive.
- 3.2 For the Authority, this is achieved by commencing the process to update and replace the Local Plan with a Local Development Plan. The first step was publishing our Development Plan Scheme in 2012 which outlines the process and timetable for preparation. The updating process of the Local Plan was informed by monitoring the progress in delivering the Local Plan and the application of its policies. The mechanism to capture this is a Monitoring report and an Action Programme. The Monitoring Statement was published alongside the Main Issues Report and is available within the background papers on line (www.ourlivepark.com). The Action Programme is to be produced alongside the Proposed Local Development Plan which will follow the Main Issues Report stage.

4 Development Plan Scheme

4.1 The last Development Plan Scheme (DPS) was issued by the Authority in December 2012 and is now out of date. The revised DPS is attached as Appendix 1 to this report for Members consideration. This includes a detailed explanation of how it is proposed the Authority produces its Local Development Plan. A summary of the key stages is as follows:

The DPS presented is in draft form and subject to approval by Members the DPS will be published for issue. After adopting the scheme, it must be published (including electronically), with two copies to be sent to Scottish Ministers and copies placed in public libraries. It is highlighted that the timescales outlined are indicative and are subject to update following a review of the responses received to the Main Issues

Report. The nature and number of responses will largely determine how long it takes to prepare the Proposed Local Development Plan.
