REQUEST FOR REVIEW OF DECISION UNDER ENVIRONMENTAL INFORMATION (SCOTLAND) REGULATIONS 2004 (the "Regulations")

Loch Lomond & The Trossachs National Park Authority received your request for review on 31st May 2017 relating to your original request for information with the reference EIR 2017-030 which you made on 10th March 2017.

Basis of Request for Review

You originally asked:

"what private roads exist in the National Park where the LLTNPA is certain that there are no public rights of passage (and therefore where campervaners could potentially be prosecuted)."

In your follow up request submitted on 31st May, you asked the Park Authority:

"to confirm whether the LLTNPA holds any information relating to whether or not there is a public right of passage on any private road within the National Park boundary and if so to provide this to me."

Assessment of relevant information

The Park Authority's original response confirmed that it did not hold information about all of the private roads within the National Park, where there are no public rights of passage. The exception under Regulation 10(4)(a) was applied to the request.

As part of this review, consideration has been given as to whether any relevant information is held, as a result of the wording of your follow up request. Further searches have been carried out. Since the date of your original request for information, the Park Authority has had some correspondence with Police Scotland regarding the temporary notice to which you refer. Your request for information relating to this notice has been handled separately as EIR 2017-47.

Decision

I have reviewed the Park Authority's original response and confirm that it was handled correctly, with the correct application of relevant exceptions.

Your further request for information relating to the temporary notices is being handled separately as EIR 2017-47.
