REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

Thank you for your request for information under the Freedom of Information (Scotland) Act 2002, received by email on 18th March 2015. Your specific requests and the relevant information held by the National Park Authority are provided below.

Section 31 of the Public Services Reform Act 2010 (PSRA) requires various public bodies to publish statements of expenditure on public relations, overseas travel, hospitality and entertainment, external consultancy, and payments in excess of £25,000 (see below).

Please supply the following information in relation to your PSRA disclosures

(a) The web links to your PSRA disclosures related to financial years 2010-11, 2011-12, 2012-13, and 2013-14, or copies if the material is not online
