### **REQUEST UNDER ENVIRONMENTAL INFORMATION (SCOTLAND) REGULATIONS 2004**

I refer to your request for information, received by email on 5<sup>th</sup> March 2018. The information you have requested is environmental information, as defined in Regulation 2 of the Environmental Information (Scotland) Regulations 2004 (EIRs). The Park Authority has an obligation to deal with your request under the EIRs and an option to also deal with your request under the Freedom of Information (Scotland) Act 2002 (FOISA), unless the public interest lies in dealing with your request solely under the EIRs. We consider that the public interest in dealing with your request under the EIRs outweighs the public interest in also dealing with your request under FOISA, on the basis that the public interest is not served by duplicating consideration of your request under both regimes. We have therefore applied the exemption in section 39(2) of FOISA and dealt with your request under the EIRs alone.

Your specific requests and the response from the National Park Authority are provided below.

### a) The Records Management Plan as supplied to the Keeper of Records

## b) The number of people LLTNPA staff requested personal details from under byelaw 9 (as opposed to the 828 people issued with warnings for breach of the byelaws).

The number of people LLTNPA staff requested personal details from under byelaw 9 in the 2017 season of the byelaws was 828.

### What I am trying to establish is whether all people who were asked for information were warned or not.

If the two figures are NOT the same, I would be grateful if you could explain to me why this is so (or failing that would ask for all information the Park holds on why some people whose personal details were collected were not issued with warnings.

# c) Any information the Park holds, including that issued to Rangers, which advises/instructs them what to do should a person previously warned be suspected of breaching the camping byelaws again.

The Park Authority Police officer and our Visitor Management Adviser were involved in delivering training to Park Authority Rangers on the application of the camping management byelaws. The interpretation of the terms of the byelaws is included in the byelaw documents.

Rangers have received scenario based training and took part in question and answer discussions to ensure they understood how the byelaws apply This includes guidance on what to do should a person previously warned be suspected of breaching the camping byelaws again. Training materials were not issued for this practical element of their training. Accordingly I have to advise under S10(4)(a) of the EIRs that information is not held.
