## **REQUEST FOR REVIEW OF DECISION UNDER ENVIRONMENTAL INFORMATION (SCOTLAND) REGULATIONS 2004 (the “Regulations”)**

Loch Lomond & The Trossachs National Park Authority received your request for review on 26<sup>th</sup> June 2017 relating to your request for information about adopted housing schemes made on 19<sup>th</sup> June 2017.

I note that the review request states that information has not been provided on housing completions. The original request asked:

**“What is your estimate of the number of housing schemes that have not been formally adopted by your Council (at least over the past 5 years (to 1<sup>st</sup> April 2017 - calendar or financial years as is easiest).”**

The response explained that as the Park Authority was neither a Roads Authority nor a Council that under S10(4)(a) of the Regulations the requested information was not held.

### Decision

I have reviewed your original request, including the proforma provided, and the exemptions and exceptions applied.

As your original request was clearly only seeking information about the non-adoption of housing schemes, the Park Authority correctly stated that under S10(4)(a) of the Regulations this information was not held and I therefore uphold the original decision.

Now that you have clarified that you were seeking information about all housing completions I can confirm that the Park Authority does hold this information and it has been provided at Annex A.

### Review Procedure

If you are not satisfied with this decision you are entitled to appeal to the Scottish Information Commissioner. Please note that in order for an appeal to take place you must lodge your appeal within six months of the date of receipt of this letter.
