## **REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002**

Thank you for your request for information under the Freedom of Information (Scotland) Act 2002, received by email on 11<sup>th</sup> November 2015. Your specific requests and the relevant information held by the Park Authority are provided below.

"What fees have been paid by the Loch Lomond and Trossachs National Park Authority to the firm of solicitors Harper and Macleod under their general overall fee agreement."

The Park Authority has engaged the services of the solicitor's firm Harper MacLeod since March 2011 to provide legal advice.

To date, £265,518 (including VAT) has been paid in legal fees by the Park Authority. The Park Authority is entitled to re-claim income from third parties for S75 agreements, which are specific planning cases. This means that part of the above figure will have been re-paid to the Park Authority from Planning applicants, however the exact figure for reclaimed fees is not available.
