There is no information relating to the National Park Authority in the bibliography and reference list that you have sent, and we have no information held in relation to this list.

Accordingly, I have to advise you under section 17(1)(b) of the Freedom of information (Scotland) Act, that this information is not held.

- Submit your review request within 40 working days of either the date on which you received a response from the Authority or the date by which you should have received a response under the terms of the Freedom of Information (Scotland) Act 2002, whichever is the later.
