# **REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002**

I refer to your request for information, received by email on 22<sup>nd</sup> June 2017. Your specific requests and the Park Authority's response are provided below.

"I would like to see copies of all profit and loss accounts together with capital expenditure for Luss Pier and Kiosk for the last 5 years. I expect this to contain details of all income and expenditure and capital investment."

Please find attached an analysis of income from Luss Pier Shop and Luss Pier for financial year ending 31<sup>st</sup> March 2016. Please note that these figures do not contain an allocation of the Park Authority staff costs for managing the pier shop and pier so total costs are understated.

We do not hold this information in an accessible way historically because the coding structure in our finance system does not record it in this format. Accordingly I have to advise under R10(4)(a) of the EIRs that this information is not held for the last five years as requested.

We will be preparing similar analysis for 2016/17 however the work is not planned to be completed until later in the financial year as it is not required until 31<sup>st</sup> March 2018 for another purpose. Accordingly I have to advise under R10(4)(a) of the EIRs that this information is not currently held.

We can confirm there has been no capital expenditure on either the pier or the pier shop since 2012.

#### Review Procedure
