REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

Thank you for your request for information under the Freedom of Information (Scotland) Act 2002, received by email on 2nd March 2016. Your specific requests and the relevant information held by the Park Authority are provided below.

Please could you forward us the most recent figures your Authority has regarding the ratio between the highest paid taxable earnings (including base salary, variable pay, bonuses, allowances and the cash value of any benefits in kind) and the median earnings figure for the whole of your Authority's work force at your earliest convenience.

The Park Authority does not pay bonuses, allowances, or any cash value benefits in kind. The median total remuneration of all staff employed by the Park Authority in financial year 2014/15 was £27,638. The pay multiple between the mid-point of the highest paid director's banding and the median total remuneration of all staff was 2.79.
