# **REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002**

I refer to your request for information, received by email on 6<sup>th</sup> December 2016. Your specific requests and the Park Authority's response are provided below.

"Please provide a full list of all those non-NPA organisations to which the LL&TNPA has provided meeting room facilities either on an ad hoc, or recurring basis, since 5th April 2016 until now. Please include in the list for each organisation, the classification category, or other group/type identifier by which the NPA distinguishes between them"

The external organisations that have booked the use of meeting room facilities; John Muir Suite, Robert Grieve Suite and the Breadalbane Room, at the Park Authority headquarters in 2016 according to category are as follows:

A list of all external organisations who have booked meeting room facilities with the Park Authority has not been provided as this information is considered to be commercially sensitive and is therefore exempt from release under S33(1)(b) of the Freedom of Information (Scotland) Act 2002. It is considered that release of the information in question would be likely to prejudice substantially the ability of the Park Authority to generate income, as organisations have made

these room bookings with no expectations that their details would be made public, and who may be dissuaded from making further bookings in future if their details were released.

The Public Interest Test was carried out in relation to the information to be withheld under S33(1)(b) of the Freedom of Information (Scotland) Act 2002. Requests for such information are considered by the Park Authority on a case by case basis. In this case, it was determined that the public interest would not be served by the release of the information.

"Please provide a full explanatory description of each classification category/group/type, relating each to the new scheme of NPA room rate charges."

If a discount is requested by a customer, they will be assessed on a case by case basis. In general the following framework will apply:-

- RAFE Partners will be given up to 100% discount;
- Registered Charities will be given up to 50% discount
- Local Groups will be given up to 25% discount;
- Partners will be given up to 100% discount;

The activity and work of the booking organisation or the particular circumstances of the request for facilities will inform whether they qualify for a discount, which will be at the Park Authority's discretion.

"Please state by organisation, both the published NPA room rate, and the actual room rate being charged, and include a full detailed explanation for any differences between these two rates including applicable rate discount schemes in operation."

Discounts are applied to some organisations, as explained above.

A list of the room rates paid by specific organisations has not been provided as this information is considered to be commercially sensitive and is therefore exempt from release under S33(1)(b) of the Freedom of Information (Scotland) Act 2002. It is considered that release of the information in question would be likely to prejudice substantially the ability of the Park Authority to generate income, as organisations have made these room bookings with no expectations that their details would be made public, and may be dissuaded from making bookings in future if their details were released.

The Public Interest Test was carried out in relation to the information to be withheld under S33(1)(b) of the Freedom of Information (Scotland) Act 2002. Requests for such information are considered by the Park Authority on a case by case basis. In this case, it was determined that the public interest would not be served by the release of the information.

"Please specifically list all organisations receiving <u>free use</u> of any rooms or abated (sub-commercial) rates for space they occupy in NPA buildings for whatever purpose, or which benefit from free or subsidised use of NPA 'office support services' or receive any other comparable benefits in kind."

The criteria applied by the Park Authority for room bookings has been explained above. Over and above the rooms that are available for external use (John Muir Suite, Robert Grieve Suite and the Breadalbane Room) we have some partner organisations that have staff located in the National Park Headquarters building at Carrochan.

Details of arrangements with partner organisations are considered to be commercially sensitive and therefore exempt from release under S33(1)(b) of the Freedom of Information (Scotland) Act 2002. It is considered that release of the information in question would be likely to prejudice substantially the agreements between the Park Authority and these organisations.

The Public Interest Test was carried out in relation to the information to be withheld under S33(1)(b) of the Freedom of Information (Scotland) Act 2002. Requests for such information are considered by the Park Authority on a case by case basis. In this case, it was determined that the public interest would not be served by the release of the information.

"Please include any and all such arrangements where similar *quid pro quo* agreements may exist, and state the quantity and commercial value of such subsidies, and explain in detail the resulting loss of revenue to the taxpayer arising from these unpublished NPA arrangements, and why these have been selectively applied to some, but to the exclusion of other organisations. Please ensure that, inter alia, coverage of these situations include those specifically of Friends of Loch Lomond, and Love Loch Lomond. Please identify the responsible NPA executive officer who approves such concessions."

The use of space in Park Authority premises by partner organisations who are delivering projects that benefit the National Park is not a commercial arrangement. The benefit to the Park Authority and the National Park overrides commercial considerations. Accordingly, I have to advise you under section 17(1)(b) of the Act, that the Authority holds no information on this subject.

Categories of room hire charges and discount rates, as well as partnership working agreements whereby external organisations have staff located on Park Authority premises are approved by the Park Authority Executive team.
