Thank you for your request for information under the Freedom of Information (Scotland) Act 2002, received by email on 24<sup>th</sup> March 2016. Your specific requests and the relevant information held by the Park Authority are provided below.

Please could you supply me with a copy of the Trail Hunting Licence you have in place (if appropriate?) for Fox Hunts to Trail Hunt in the NP. Including copies any daily record sheets that may be required by the Fox Hunts to fill in each time they Trail Hunt on NP land/property, this may include forms filled in after the planned day's Trail Hunting and maps filled in before the planned day's Trail Hunting.

We do not have a Trail Hunting Licence in place for fox hunts to trail hunt in the National Park. Therefore we do not have the information you requested.

We are not aware of trail hunting happening within the National Park, but this would be a matter for private landowners.
