REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

Thank you for your request for information under the Freedom of Information (Scotland) Act 2002, received by email on 24th May 2016. Your specific requests and the relevant information held by the Park Authority are provided below.

Between 2010 and the end of 2015, how many visitors have you recorded visiting your national park.

The Park Authority does not record visitor numbers to the National Park. Accordingly, I have to advise you under section 17(1)(b) of the Freedom of Information (Scotland) Act 2002 that this information is not held.

You may however be interested to know that In 2011 the National Park Authority commissioned a report called Valuing the National Park to update the National Park's economic baseline, to consider its contribution to the Scottish economy and assess the value of the Park's ecosystems. The report was completed in July 2011.

How many school visits has your national park received each year between 2010 and 2015.
