## Types, Locations, Frequency, Responsibilities

### Luss



Two NPA bins situated at the back of the bus stop and one in front of the bus stop. These are on Argyll and Bute Land and checked/emptied and litter picked on a daily basis by NPA Land Operations Team.





There are two of these large node recycling bins at Luss Car park. They belong to and are on NPA land and the NPA contracts with Argyll and Bute Council to empty these twice weekly from April to October. NPA Land Operations Team carry out litter picking around these bins on a daily basis when they are overflowing.



Two NPA bins at left hand side of Luss Pier, another at the right hand side of pier and one at the bottom of the road adjacent to the pier. These are probably on Luss Estates Land but NPA Land Operations Team service these bins and litter pick on a daily basis.





NPA bins outside Luss Village café in group of four. These are on Argyll and Bute Land and are serviced daily and litter picked by NPA Land Operations Team. This is the location that one of three Big Belly bins was trialled last year.



There are ten round bins around Luss which belong to and are emptied by Argyll and Bute Council (frequency unknown).

There are an additional two grey style bins in the Luss play area. Managed by unknown or Argyll and Bute Council.

Firkin Point



NPA Node recycling bin on our leased land at Firkin Point. The NPA contracts with Argyll and Bute Council to empty these twice weekly April to September.

The NPA Land Operations Team litter pick the site on a daily basis during the season.

<u>Tarbet</u>



NPA Recycling node bin on our land at Tarbet. NPA contracts with Argyll and Bute Council to empty these twice weekly from April to September.

The NPA Land Operations Team litter pick the site on a daily basis during the season.

Inveruglas



NPA Recycling node bin next to Inveruglas Visitor Centre and Toilets on our land leased from SSE. NPA contracts with Argyll and Bute Council to empty these twice weekly from April to September.

The NPA Land Operations Team litter pick the site on a daily basis during the season.

#### Milarrochy Bay



We have two of these NPA blue bins at Milarrochy Bay primarily for dog waste on our land leased from Montrose Estates which are checked/emptied daily by NPA Land Operations Team.



Three large industrial bins adjacent to the building owned and emptied by Stirling Council weekly. There has been a recent addition of two large red recycling bins at Milarrochy Bay by Stirling Council and are the responsibility of the council.



### <u>Balmaha</u>



We have a grey bin directly outside Balmaha Visitor Centre and one further near the back of the car park. These are emptied daily by NPA Land Operations Team.



Large commercial bins at the right of Balmaha Visitor Centre emptied weekly by Stirling Council.



There are two Stirling Council bins at/near the bus stop. There is some confusion over responsibility as the land is intended to transfer to FOLLAT.

The NPA Land Operations Team litter pick the site on a daily basis during the season.

# Duncan Mills Memorial Slipway



There are two burgundy wheeled bins and three wheeled recycle bins belonging to West Dunbartonshire Council which are emptied by the council once a week. There are three red Biffa non –moveable skips in the area, one of which is leased by NPA and emptied by Biffa and this is for Contractor Waste only.

### Loch Venachar and Kingshouse



We lease a skip at Loch Venachar in which we pay for monthly collection, however additional collections are arranged as and when the Rangers report that the skip is full. This was brought in as somewhere to dispose of the rubbish that the Rangers collect around this area.

There is also a skip on Forestry Commission land at

Kingshouse which the Forestry Commission pay for the servicing of. This is also used by NPA Rangers to dispose of the rubbish collected around the area.
