| 5 | <p>Tree Preservation Order Recommendations – TPO Review - 2018/0011/TPO – variation – Donich View, Lochgoilhead</p> <p>Consideration of Item</p> <p>Woodland Adviser (SF) presented the report and advised that one representation had been received. SF then put forward the recommendation of the Director of Rural Development and Planning, to:</p> <p>a) Note that Loch Lomond & The Trossachs National Park Authority (Land To The North Of Donich View, Lochgoilhead, Argyll) Tree Preservation Order (No. 11(2005)) confirmed on 24th April 2006 (the “Original Order”) was varied on 17th August 2018 by the Loch Lomond and The Trossachs National Park Authority (Tree Preservation Order Number 11 of 2018 (the Variation Order)) with approval of the Chair of the Planning & Access Committee (Reference: 2018/0011/TPO)</p> <p>b) Confirm the Variation Order without further modification.</p> <p>Members asked questions of officers and discussion took place regarding the proposed recommendations.</p> <p>Members sought clarification on how the total score of 24 was reached in section 8.4 of the report:</p> <p>8.4 On the above basis the woodland scored 24 with a score greater than 21 indicating a TPO is definitely merited. The total score is based on 8 (out of 10) for condition, 10 (out of 10) for naturalness (although not listed in the Ancient Woodland Inventory the woodland is recorded on the 1866 OS 1st edition map and is thus of sufficient age to be considered an ancient woodland); and 2 (out of 10) for size. The expediency rating was 1 (out of 5).</p> <p>SF and SM referred to the original Woodland Evaluation Method for Preservation Orders guidance document and advised that section 8.4 should have included reference to 2 as a cultural factor and that the expediency rating should also be detailed as 2 (out of 10) to give a total score of 24.</p> <p>Following this clarification, the Chair asked for a proposer for the motion of the officer’s recommendation to:</p> <p>a) Note that Loch Lomond & The Trossachs National Park Authority (Land To The North Of Donich View, Lochgoilhead, Argyll) Tree Preservation</p> | |

| 7 | <p>Planning (Scotland) Bill – verbal update</p> <p>SM provided a verbal update on the current status of the Planning (Scotland) Bill in the parliamentary process. SM advised Members that it was an action from the 10th December 2018 Board meeting that “Board Members delegated authority to the Planning & Access Committee to provide comment formally on the Planning (Scotland) Bill”.</p> <p>SM advised Members that there is no formal process as a non-departmental public body to comment and that our position is reflected in that of Local Authorities, the Royal Town Planning Institute, the Law Society, the Heads of Planning and Convention of Scottish Local Authorities.</p> <p>SM informed members that Petra Biberbach, the previous Chair of the Park Authority Planning & Access Committee sat on the Independent Panel which was established by Scottish Ministers to review the planning system.
