REQUEST UNDER ENVIRONMENTAL INFORMATION (SCOTLAND) REGULATIONS 2004

We refer to your request for information, received by email on 20th June 2019. The information you have requested is environmental information, as defined in Regulation 2 of the Environmental Information (Scotland) Regulations 2004 (EIRs). The Park Authority has an obligation to deal with your request under the EIRs and an option to also deal with your request under the Freedom of Information (Scotland) Act 2002 (FOISA), unless the public interest lies in dealing with your request solely under the EIRs. We consider that the public interest in dealing with your request solely under the EIRs outweighs the public interest in also dealing with your request under FOISA, on the basis that the public interest is not served by duplicating consideration of your request under both regimes. We have therefore applied the exemption in section 39(2) of FOISA and dealt with your request under the EIRs alone.

Your specific requests and the response from the National Park Authority are provided below.

“I would request that you provide me with the following information relating to the Luss Visitor Centre:

- a. A copy of the floor plans of all floors of Luss Visitor Centre as part of Application LL 2745 approved by Dumbarton District Council in their letter dated 11 August 1993 to the Loch Lomond Park Authority.”**

West Dunbartonshire Council may have copies of the original plans submitted with these warrants, however we do not hold this information. Accordingly we have to advise under Regulation 10(4)(a) of the EIRs that this information is not held. We have attached copies of information relating to the building warrants held by West Dunbartonshire Council in Appendix A which we hope may be helpful.

- b. “A copy of all the current floor plans for Luss Visitor Centre if different from the floor plans as part of Application LL 2745 approved by Dumbarton District Council in their letter dated 11 August 1993 to the Loch Lomond Park Authority.”**

A copy of the current floor plans for Luss Visitor Centre is attached in Appendix A.

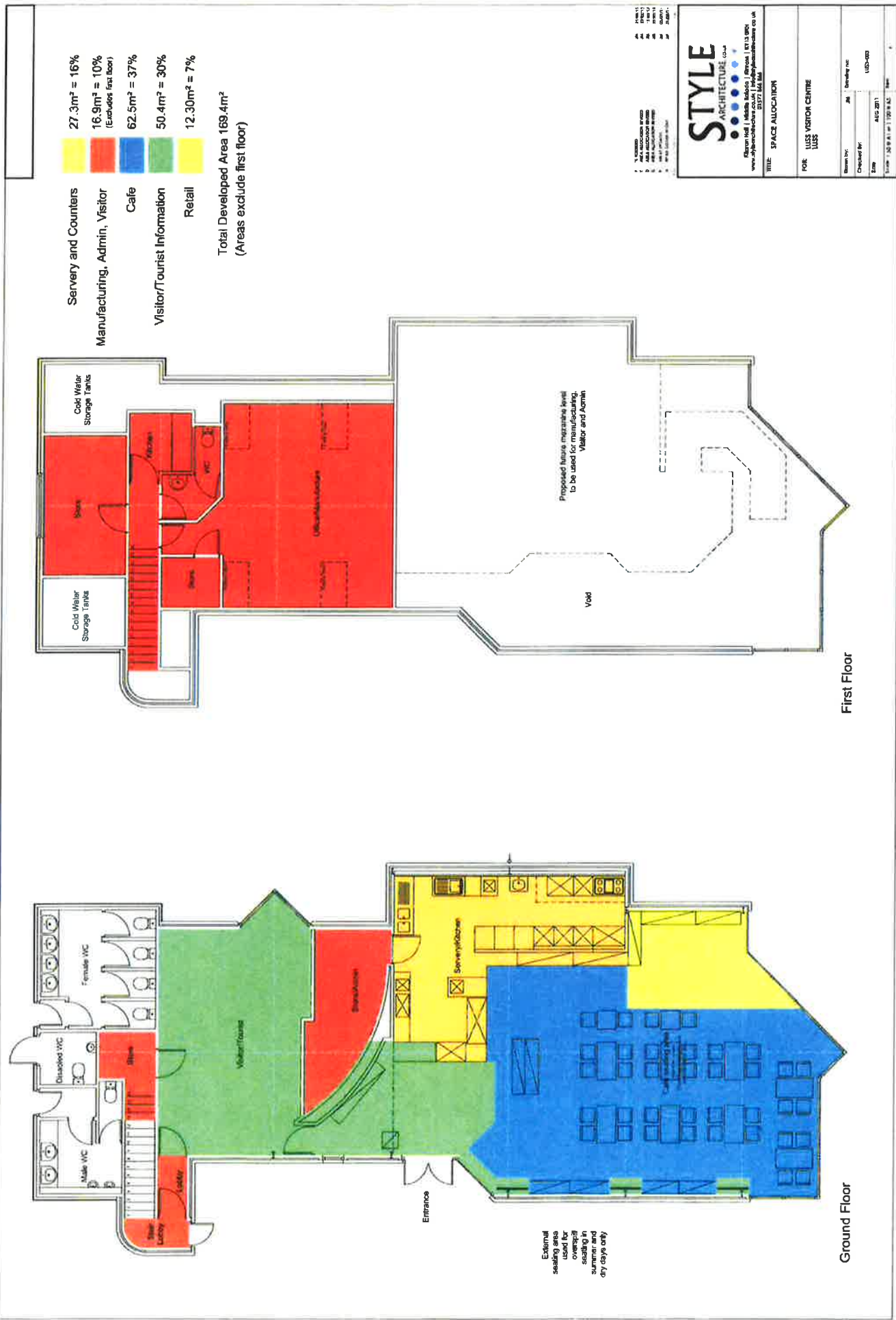
