REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

We refer to your request for information, received by email on 20th April 2019. Your specific requests and the Park Authority's response are provided below.

"We are looking specifically for data on your tendering process for First Aid training courses."

Does your organisation use internal trainers to run first aid courses?

The Park Authority does not use internal trainers to run first aid courses. Accordingly, we have to advise you under section 17(1)(b) of the Act, that this information is not held

Does your organisation buy in external providers to deliver first aid courses?

Yes, the Park Authority uses external providers to deliver first aid courses.

If the answer to Question 2 is yes, what criteria are used to select the training provider?

Any training provider selected is required to demonstrate suitable experience, qualifications, insurance and evidence of good written and oral communications skills. They are usually required to be able to deliver first aid and forestry first aid training for up to twelve people at a time regardless of whether it is emergency first aid or refresher for full course. The majority (if not all) of this type of training is undertaken at our facilities.

Does your organisation have any contracts/tenders relating to first aid training?

No, the current value of spend is very low so we are not required to tender for first aid training contracts.

If the answer to Question 3 is YES are these contracts/tenders relating to first aid training part of a larger contracts/tender?

N/A, see previous answer above.

If you have any tenders relating to first aid training what is the value of these tenders, particularly the first aid element of these contracts/tenders?

As explained above, we do not currently have any tenders relating to first aid training.
