



# TERMS AND CONDITIONS (#LochdownChallenge)

By entering this competition entrants accept these terms and conditions and agree to be bound by them:

### **WHO MAY ENTER**

- The competition is open to residents of the United Kingdom except employees of Loch Lomond and The Trossachs National Park Authority (the "Park Authority") and their close relatives and anyone otherwise connected with the organisation or the judging of the competition, including the suppliers of prizes.
- The entrant must be 18 years old at the date of entering the competition. The entrant may be asked to provide proof of age if they are chosen as a winning entry.
- 3. The entrant is the person who manages the profile of the submitted entry.
- 4. Use of a false name, age or address will result in disqualification.
- There is no limit on the number of entries each person can submit to take part in the competition but no more than one prize shall be awarded.

## **HOW TO ENTER**

- 1. There is no fee to enter this competition.
- 2. The entrant ("you") can enter the competition by posting your competition entry on your Twitter, Instagram or Facebook account.
- To enter the competition on Twitter, Instagram or Facebook, you must tag your post with #LochdownChallenge and @ lomondtrossachs. Entries must include a photograph, a humorous description of the photograph and link in some way to the National Park.
- 4. When posting on Twitter you will need to unprotect your tweets to make them public. You can do this in the 'Settings and Privacy' section of your account. Alternatively, you can send the Park Authority a direct message with your entry and tag your post with #LochdownChallenge.
- When posting on Facebook make sure your post is 'Public' and not just shared amongst your friends.
- The closing date for entries is no later than 23.59 on 14th June 2020 ("the closing date"). No further entries to the competition will be accepted after the closing date.
- The Park Authority cannot accept responsibility for entries lost, corrupted or not received by the closing date, for whatever reason.

## PRIZES, WINNER SELECTION AND NOTIFICATION

- One winner will be chosen from all entries by the Park Authority staff on or before 13th July 2020. All entries will be shortlisted by a National Park representative and shortlisted entries will then be voted on by all National Park Authority staff.
- 2. The prize is a Vango Stargrove II Air 450 and a two-night stay for up to four people at one of our Park Authority campsites at either Loch Chon or Loch Achray once they have reopened.
- 3. The prizes are as stated and no cash or other alternatives will be offered. The prizes are not transferable. Prizes are subject to availability and the Park Authority reserves the right to substitute any prize with another of equivalent value without giving notice.
- 4. Unless expressly stated within these terms and conditions, all other expenses relating to the prize are the responsibility of the winner and his or her guests. For the avoidance of doubt the prize excludes any costs for transport, travel, accommodation, spending money, meals, travel documentation and insurance other than as specified.
- 5. Third party terms and conditions and the Park Authority terms and conditions relative to its campsites may apply to the prizes. Acceptance of the prize is deemed to be acceptance of any such terms and conditions applicable to the prize.
- 6. Entries will be shortlisted on the following criteria:
  - How creative the photograph is (score out of five, 1 being not at all 5 being most)
  - How humorous the description is (score out of five as above)
  - How closely linked the activity is to the National Park (score out five as above).
- 7. The winner shall be notified that he or she has won a prize no later than 13th July 2020 via the social media platform used to submit the winning entry. In order to claim his or her prize, the winner must contact the Park Authority by sending a private message through the social media channel used to enter the competition within fourteen (14) days of being notified that he or she is a winner and confirm acceptance of the prize and any third party or other conditions pertaining thereto. If the winner cannot be contacted or does not claim the prize within fourteen (14) days of notification, the Park Authority reserves the right to withdraw the prize from the winner and award the prize to an alternative winner selected by the same judges.
- 8. Once the winner has claimed their prize, the Park Authority will confirm when and where the prize can be collected / delivered. Prizes will only be available after all Covid-19 lockdown restrictions have been lifted by Scottish Government. The Park Authority campsite stay can be used before 30th September 2020 if campsites are able to reopen in the 2020 season, or alternatively can be arranged between 1st March and 30th September 2021.
- 9. The judges' decision in respect of all matters to do with the competition will be final and binding in all respects on all entrants and no correspondence will be entered into.

### **PERSONAL DETAILS**

The Park Authority will use the personal details of all entrants (and anyone depicted in the photographs) for the purpose of administering this competition, including prize fulfilment and announcing the winner and using and displaying the winning photograph on its website and social media. The personal data of all entrants will be processed securely in accordance with the Data Protection Act 2018.
