#### **PRIVACY NOTICE - VOLUNTEERS**

This notice provides details of what information we collect from you, what we do with it, and who it might be shared with in the course of your volunteering activities with the National Park Authority

# What information do we collect about you?

We may collect the following information (but only where relevant to your particular circumstances):

- Forename
- Surname
- Date of Birth
- Home address
- Home telephone number
- Mobile number
- Email address
- Medical conditions
- Dietary requirements
- Next of kin details
- Photographs of you undertaking volunteer activities

We also keep copies of your communications with us and our responses.

# Who might we share your information with?

We may share your information with organisations that we work closely with to provide volunteering opportunities such as Scottish Natural Heritage, National Trust for Scotland and Friends of Loch Lomond and The Trossachs. We will seek your permission first before sharing your details with other organisations. We will generally comply with requests for specific information from other regulatory and law enforcement bodies where this is necessary and appropriate.

### Will we send your information outwith the UK?

## How long do we keep hold of your information?

We keep hold of your information until three years after you no longer volunteer with us. Your information will be retained for the minimum period necessary. Your information will be destroyed under confidential conditions after this period.

### What are my rights in relation to the information held about me?

You have the following rights:

- To see any information held about you by making a subject access request, details of this

- To withdraw consent at any time, where the legal basis for processing is consent.
- To data portability, where the legal basis for processing is (i) consent or (ii) performance of a contract.
- To request rectification or erasure of your information, where data protection legislation allows this.
