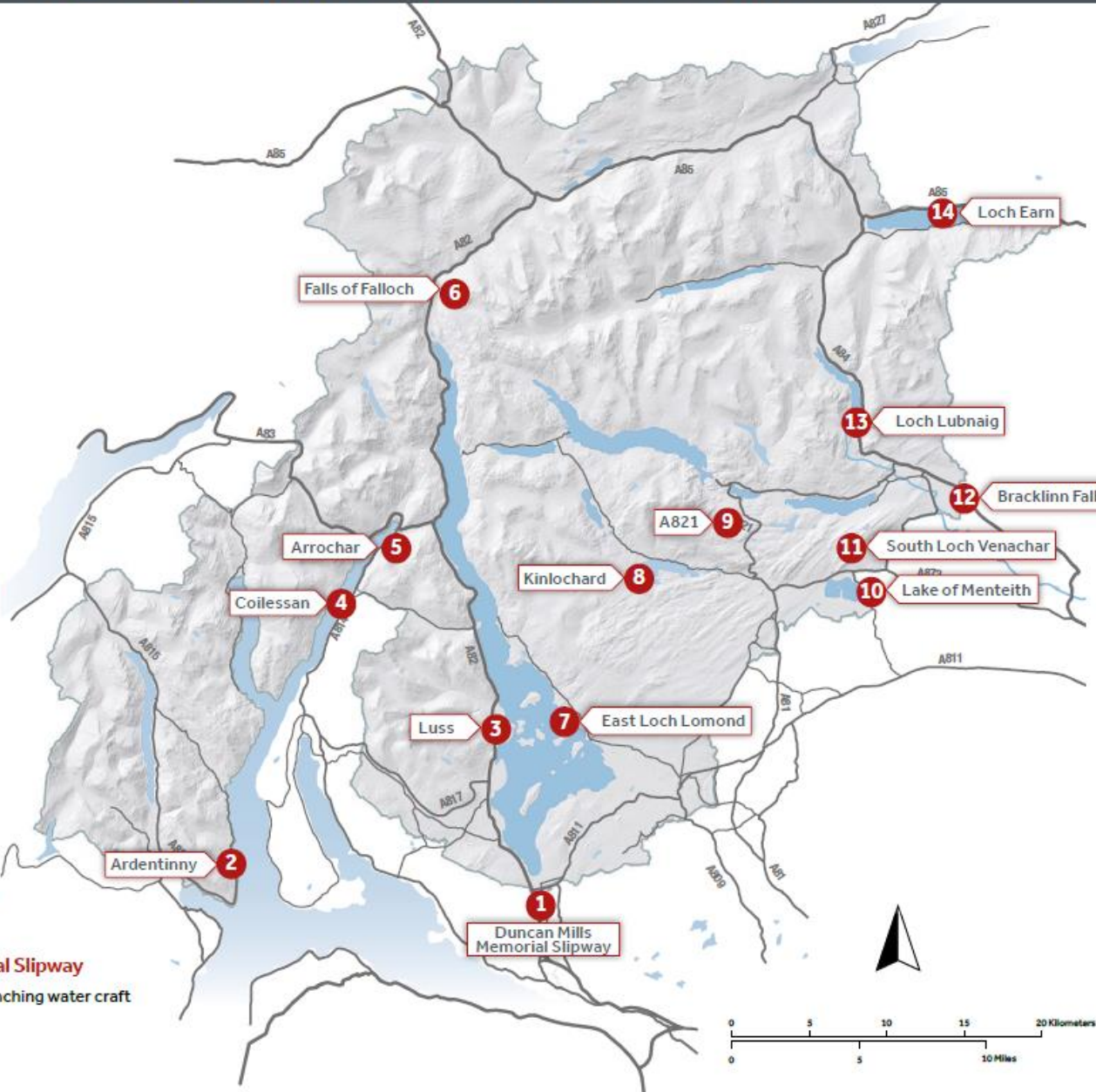

 - Irresponsible toileting (Permit Areas & opposite St Fillans)

 - Antisocial behaviour with Personal Water Craft
