REQUEST UNDER ENVIRONMENTAL INFORMATION (SCOTLAND) REGULATIONS 2004

We refer to your request for information, received by email on 7th May 2021. The information you have requested is environmental information, as defined in Regulation 2 of the Environmental Information (Scotland) Regulations 2004 (EIRs). We have therefore applied the exemption in section 39(2) of FOISA and dealt with your request under the EIRs alone.

Your specific requests and the response from the National Park Authority are provided below.

"I see you have 6 camping zones now for sale in the Loch Ard camping zone. This size of area and geography has a maximum 3 camping zones. Please furnish me with your locations of the 6 camping sites and emergency access.

There is one camping management zone which covers the area around Loch Ard, stretching up to Loch Chon and Loch Arklet. The extent of this management zone known as Trossachs West, is detailed in Page 25-29 of the byelaw booklet http://www.lochlomond-trossachs.org/wp-content/uploads/2017/02/Camping-Management-Byelaws-2017.pdf

People may camp responsibly anywhere outside of the purple area in accordance with the Scottish Outdoor Access Code: https://www.outdooraccess-scotland.scot/
From March to September, people camping inside the purple area can only do so at a camping permit area or campsite.

Within this Camping Management Zone, there is one camping permit area and one campsite where people can book and stay on. Details are as follows:

 Camping Permit Area on Loch Ard (south western corner near Couligarten) maximum of six permits permitted (i.e. six tents) per night

○ Loch Chon Campsite (eastern shore) – 26 pitches

Using the forestry trails that are predominant in the area, people are able to access the southern shore of Loch Ard and the western shore of Loch Chon on foot, and camp outside of the area covered by the Camping Management Byelaws.

When people book in to a campsite and camping permit area they are provided with information on how to access the area and where they can park their cars so they are as prepared as possible. Grid references are provided on bookings to help people, and if required emergency services, locate the area. Should people require the emergency services they should contact them by calling 999.

"can you provide me information on your planned camping zones for the next 5 years."

There are no other planned camping areas at this time within this area. Accordingly we have to advise under Regulation 10(4)(a) of the EIRs that this information is not held.
