## **REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002**

We refer to your request for information, received by email on 22<sup>nd</sup> June 2022. Your specific requests and the Park Authority's response are provided below.

**“Could you please provide data on Loch Lomond and The Trossachs National Park Authority's total annual spend on fair trade goods throughout each of the past two annual accounts? (i.e. data from both 2020-2021 and 2021-2022). Could you break it down by vendor name; whether they were contracted/non-contracted; description of item(s) purchased; and the total value per order? I've attached an example below for further clarification. Could you also include items purchased for resale?”**

During the last two financial years (throughout the Covid pandemic) all financial expenditure has been recorded by purchase order. The description on the purchase order, rather than invoice descriptions are recorded in our systems. Searches of all supplier payments for the past six years have found no record of the requested terms.

Accordingly, we have to advise you under section 17(1)(b) of the Act, that this information is not held. We would like to clarify that this does not necessarily mean that there have been no goods, services or works procured by the Park Authority which could be categorised as fair trade, our records do not include the use of this category of information.

**“Could you also attach your current general policy on the procurement of fairly and ethically traded goods and services, in line with section 15(5)(b)(v) of the Procurement Reform (Scotland) Act 2014?”**

The relevant extract from our procurement policy which covers fair trade is as follows:
