HOW TO REGISTER

You are required to complete the form overleaf, read guidance notes below and explanatory notes (separate sheet) before completing the form.

GUIDANCE NOTES

The Loch Lomond Byelaws were introduced to reduce disturbance to wildlife, local people and visitors and to promote safety. The Byelaws require that all owners of all motorised vessels on Loch Lomond register their vessel with Loch Lomond & The Trossachs National Park Authority (NPA) and display the registration number on their vessel as per the prescribed manner.

All registered owners and/ or users of motorised vessels on Loch Lomond and their guests use Loch Lomond and any related facilities and/ or equipment entirely at their own risk. The NPA and its employees and agents shall under no circumstances whatsoever be liable to any person, whether in contract, delict (including negligence), breach of statutory duty, or otherwise, for any liabilities, loss of profit, costs, penalties, expenses, revenue, income, damages or any direct or indirect or consequential loss arising as a result of or in connection with the use of a motorised vessel on Loch Lomond. All warranties, conditions, guarantees, representations and other terms implied by statute or common law are, to the fullest extent permitted by law, excluded by the NPA. Nothing in these conditions excludes the liability of the NPA for death or personal injury directly caused by the NPA's negligence or fraud or fraudulent misrepresentation on the NPA's part.

FEES

There is an optional voluntary Annual Operations donation of £30 requested at point of registration & re-registration; this is in line with the registration period of 1 February – 31 January. This includes the supply of materials required to display your registration number.

This payment will contribute towards services on Loch Lomond including Ranger Service patrols and the Loch Lomond Rescue Boat. Should you choose to not pay this voluntary amount then a payment of **£8.00** is required to supply the materials to display your registration number. Please remember to include the cost of postage where required.

MULTIPLE LAUNCH PASS FEE (APPLICABLE)

This is an annual payment to use any National Park Authority launch facility. It is set at **£100 per vessel per annum**. Valid period covers 1 year from date of payment.

SINGLE LAUNCH FEE (APPLICABLE)

Only available for purchase on the day

This is a payment to accommodate first time or infrequent visitors. For a single use of our launch facility (launch & retrieval) the fee is set at **£25 per vessel**.

For a single launch or retrieval the fee is set at **£12.50 per vessel**.

Once we have received your completed form (the address is at the bottom of this page), the Registration officer will make contact to arrange payment over the telephone. (NB: We cannot process your payment before we receive your completed form.)
