Statement supporting submission of Arrochar, Tarbet and Ardlui Local Place Plan to Loch Lomond & The Trossachs National Park Authority

11 April 2023

0. INTRODUCTION

This statement accompanies the submission of Luss and Arden Local Place Plan to the National Park Authority by Arrochar, Tarbet and Ardlui Community Council. The Local Place Plan and this statement have been prepared in accordance with:

The Plan covers the Arrochar, Tarbet and Ardlui Community Council area, which stretches from Glen Croe and Ardgartan through Succoth, Arrochar and Tarbet, along upper Loch Lomond through Inveruglas and Ardlui, almost to Inverarnan at the foot of Glen Falloch (including the Arrochar Alps and the northern part of the Luss Hills). A map of the Community Council area can be seen in the Plan.

The primary purpose of the Plan is to provide an up-to-date statement of current issues we face and our aspirations for the next 5-10 years, to help public bodies, landowners, businesses and funders consider how they can best support posi1tive change in the area.

There are three strategic objectives (retain and attract families, strengthen the local community and manage visitor pressure) and six priority action areas: Life in the Community, The Environment, Population and Homes, Visitors, Getting About and Jobs & Business.

As explained on page 7 of the Local Place Plan, it reflects national planning policy aims of creating sustainable, liveable and productive places as expressed in NPF4. The Plan takes account of the other documents in developing the vision, priorities, aims and actions contained in sections 3 and 4 of the Plan, alongside the community issues and aspirations summarised in section 2 of the Plan.

4. SUPPORT FOR THE LOCAL PLACE PLAN

The community engagement process used to develop the Local Place Plan, along with the levels of participation, is explained in section 2 of the Plan (pages 8 to 29).

The Community Council is satisfied that the Local Place Plan provides an accurate and evidencebased view of local residents and should be treated as representing 'the voice of the people'.

A number of reports document each of the four main stages of community engagement:

- 1. Report of community survey results (included in Local Place Plan as appendix).
- 2. <u>Report of first community event</u>.
- 3. <u>Report of second community event</u>.
- 4. <u>Report of consultation responses to draft Plan</u>.

Each stage of engagement was overseen by a steering group drawn from different parts of the Community Council area, the majority not being members of the Community Council. The steering group met approximately once a month and was closely involved in each stage of the process.

The Local Place Plan proposes some changes to the current local planning and policy framework. 
