## Statement supporting submission of Luss & Arden Local Place Plan to Loch Lomond & The Trossachs National Park Authority

## 0. INTRODUCTION

This statement accompanies the submission of Luss and Arden Local Place Plan to the National Park Authority by Luss and Arden Community Council. The Local Place Plan and this statement have been prepared in accordance with:

## 3. REGARD GIVEN TO EXISTING PLANS

In preparing the Local Place Plan, the community had regard to the following plans:

- National Planning Framework 4 (NPF4)
- Loch Lomond and the Trossachs Local Development Plan adopted in 2016
- <u>West Loch Lomondside Rural Development Framework</u>: Supplementary Guidance, 2017
- Helensburgh and West Lomond Locality Plan 2017-18
- Loch Lomond and the Trossachs National Park Plan 2018-2023
- West Loch Lomond Strategic Tourism Infrastructure Development Framework 2022

As explained on page 7 of the Local Place Plan, it reflects national planning policy aims of creating sustainable, liveable and productive places as expressed in NPF4. The Plan takes account of the other documents in developing the vision, priorities, aims and actions contained in sections 3 and 4 of the Plan, alongside the community issues and aspirations summarised in section 2 of the Plan.

### 4. SUPPORT FOR THE LOCAL PLACE PLAN

The community engagement process used to develop the Local Place Plan, along with the levels of participation, is explained in section 2 of the Plan (pages 8 to 29).

The Community Council is satisfied that the Local Place Plan provides an accurate and evidencebased view of local residents and should be treated as representing 'the voice of the people'.

A number of reports document each of the four main stages of community engagement:

- 1. Report of community survey results (included in Local Place Plan as an appendix).
- 2. <u>Report of first community event</u>.
- 3. <u>Report of second community event</u>.
- 4. <u>Report of consultation responses to draft Plan</u>.

Each stage of engagement was overseen by a steering group drawn from the local community, with a diversity of ages from school age to retirement, from different parts of the Community Council area, and the majority not being members of the Community Council. The steering group met approximately once a month and was closely involved in each stage of the process.

#### 5. AMENDMENTS TO THE LOCAL DEVELOPMENT PLAN

The Local Place Plan proposes some changes to the current local planning and policy framework. These are listed in a table on pages 64-65 of the Local Place Plan, together with reasons for the proposed changes. Each proposed change is explained in more detail in the relevant part of Section 4 of the Local Place Plan, as detailed in the table.
