We refer to your request for information, received by email on 1st May 2023. Your specific requests and the Park Authority's response are provided below.

"Please may you provide me with:

- The total amount spent in the last five financial years on public relations, both in-house and externally (split if possible).
- The total number of public relations officers or communications officers employed by your organisation over the last five years

Please provide the information in the form of an Excel spreadsheet if at all possible."

The total amount spent by the National Park Authority in the last five financial years on public relations is shown in the table below, with a breakdown of the spend shown in the attached spreadsheet Appendix A.

The figures include costs paid externally for consultants, subscriptions and photography. In financial year 2018/19 the National Park Authority employed an external PR agency. In financial year 202/21 there was no public relations spend at the height of the global pandemic.
