REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

We refer to your request for information, received by email on 8th November 2023. Your specific requests and the Park Authority's response are provided below.

"I would like to request the following information under the Freedom of Information Scotland Act 2002 (FOISA):

1) The current Risk Register you hold."

The National Park Authority's current risk register is attached in Appendix A. Some information in this document has been withheld from release under S30(c) of FOISA as it is considered that the release of this information would otherwise prejudice substantially, or be likely to prejudice substantially, the effective conduct of public affairs.

Application of public interest test

In respect of the withheld information under Section 30(c) of FOISA), we have considered the public interest test, i.e. the public interest in favour of disclosure balanced against the public interest in maintaining the exemption. In considering the public interest, we have considered matters that are of serious concern or benefit to the public and not merely someone's individual interest.

Public interest in disclosure

We recognise that there is a public interest in relation to transparency of decision-making procedures on matters such as the one to which this information request relates. There is a public interest in individuals being able to exercise their rights under FOISA in order to enhance their understanding of the work of a public authority and ensure openness and accountability in relation to the management of public assets.

Public interest against disclosure

LOCH LOMOND & THE TROSSACHS NATIONAL PARK AUTHORITY

The National Park Authority's risk register contains details of identified risks and mitigating actions, to help it manage risk. Headline risks are recorded in our annual report, however the information in the risk registers is more detailed and includes an evaluation of identified risks as well as mitigation action to be taken.

We are mindful of the importance in taking a proportionate approach to the application of any exemptions under FOISA and have considered each of the risks recorded in the register, to look at the likely harm to be caused by the disclosure of details in relation to each risk. The risk name and description of all but one risk have been disclosed. The only risk which has been completely withheld from release relates to current legal proceedings as it is considered that release would have a detrimental impact on these proceedings.

The categories for which some mitigation actions have been withheld are as follows:

- Business continuity and cyber security
- Health and safety
- Legal risk
- Medium term budget

For a risk register to be effective, it must be based on an honest assessment of the challenges faced by an organisation and how they can be overcome. It is considered by the National Park Authority that any disclosure which has the effect of undermining the effective operation of the National Park Authority, which includes the consideration of risks would also be likely to prejudice substantially the effective conduct of public affairs for the purposes of section 30(c).

It is considered that the public interest in the release of the mitigation actions associated with the above categories is outweighed by the greater public interest in the National Park Authority effectively managing financial, legal and infrastructure risks as part of its responsibilities as a non-departmental public body.
