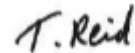

Executive Summary

Executive summary

Audit conclusions and significant findings

The detailed scope of our work as your appointed auditor for 2023/24 is set out in Audit Scotland's Code of Audit Practice 2021. Our responsibilities and powers are derived from our appointment by the Auditor General under the Public Finance and Accountability (Scotland) Act 2000 and as outlined in our Annual Audit Plan, our audit has been conducted in accordance with International Standards on Auditing (UK) and means we focus on audit risks that we have assessed as resulting in a higher risk of material misstatement.

In section 4 of this report we have set out our conclusions and significant findings from our audit. This section includes our conclusions on the audit risks and areas of management judgement in our Annual Audit Plan, which include:

- Management override of controls;
- Valuation of property, plant and equipment.
- Valuation of the net defined benefit liability/surplus
- Expenditure recognition; and
- Revenue recognition

Misstatements and internal control recommendations

Section 5 sets out internal control recommendations and section 6 sets out audit misstatements. Section 7 outlines our work on Loch Lomond and the Trossachs National Park Authority (LLTNPA)'s arrangements to achieve economy, efficiency and effectiveness in its use of resources.

Status and audit opinion

We have substantially completed our audit in respect of the financial statements for the year ended 31 March 2024.

At the time of preparing this report, there are matters remaining outstanding as outlined in section 2.

We will provide an update to you in relation to the matters outstanding through issuing our final annual audit report.



Audit opinion

We expect to issue an unqualified opinion, without modification, on the financial statements. Our proposed audit opinion is included in the draft auditor's report in Appendix B.



Regularity

We expect to issue an unqualified opinion, without modification, that in all material respects, the expenditure and income in the financial statements were incurred or applied in accordance with any applicable enactments and guidance issued by the Scottish Ministers. Our proposed audit opinion is included in the draft auditor's report in Appendix B.

Matters on which we report by exception

We are required by the Auditor General for Scotland to report to you if, during the course of our audit, we have found that adequate accounting records have not been kept; the financial statements and the audited part of the Remuneration and Staff Report are not in agreement with the accounting records; or we have not received all the information and explanations we require for our audit.

We have nothing to report in respect of these matters.



Other information

We are required to report on whether the other information (comprising of the Performance Report and the Accountability Report and the unaudited parts of the Remuneration and Staff Report), is materially inconsistent with the financial statements; is materially inconsistent with our knowledge obtained in the course of the audit; or is materially misstated.

No inconsistencies have been identified and we have issued an unmodified opinion in this respect.

Wider Scope conclusions

As auditors appointed by the Auditor General of Scotland, our wider scope responsibilities are set out in Audit Scotland's Code of Audit Practice 2021. The Code requirements broaden the scope of the 2023/24 audit and allows us to use a risk-based approach to report on our consideration of the Loch Lomond and the Trossachs National Park Authority (LLTNPA's) performance and make recommendations for improvement and, where appropriate, conclude on LLTNPA's performance.

The Code's wider scope framework is categorised into four areas:

- financial management;
- financial sustainability;
- vision, leadership and governance; and
- use of resources to improve outcomes.

It remains the responsibility of LLTNPA to ensure proper financial stewardship of public funds, it complies with relevant legislation and establishes effective governance of their activities. LLTNPA is also responsible for ensuring that it establishes arrangements to secure continuous improvement in performance and, in making those arrangements, ensures resources are being used to improve strategic outcomes and demonstrate the economy, efficiency, and effectiveness throughout the use of its resources. These arrangements should be proportionate to the size and type of the NDPB, appropriate to the nature of the NDPB and the services and functions that it has been created to deliver.

Our audit work is substantially complete and there are currently no matters of which we are aware that would require modification of our audit opinion, subject to the satisfactory resolution of the outstanding matters set out below.

Audit Approach

Audit Approach

Changes to our audit approach

There have been no changes to the audit approach we communicated in our Annual Audit Plan, issued on 4 June 2024.

Materiality

Our provisional materiality at the planning stage of the audit was set at £0.293m using a benchmark of 2% of gross operating expenditure. Our Performance materiality was set at £0.205m.

Based on the final financial statement figures and other qualitative factors, the final overall materiality we applied was £0.262m, final performance materiality: £0.184m; final clearly trivial threshold: £8k.

Use of experts

There have been no changes to our use of experts outlined in our Annual Audit Plan, with no issues arising which we are required to report to you.

Service organisations

There have been no changes to LLTNPA's use of service organisations outlined in our Annual Audit Plan, with no issues arising we are required to report to you.

Significant findings

Significant findings

Significant findings, including key areas of management judgement

The significant findings from our audit include:

- our audit conclusions regarding significant risks and key areas of management judgement outlined in the Annual Audit Plan;
- our comments in respect of the accounting policies and disclosures that you have adopted in the financial statements. On page 19 we have concluded whether the financial statements have been prepared in accordance with the financial reporting framework and commented on any significant accounting policy changes that have been made during the year;
- any further significant matters discussed with management;
- any significant difficulties we experienced during the audit.

Significant findings

Management override of controls

Description of the risk

Management at various levels within an organisation are in a unique position to perpetrate fraud because of their ability to manipulate accounting records and prepare fraudulent financial statements by overriding controls that otherwise appear to be operating effectively. Due to the unpredictable way in which such override could occur there is a risk of material misstatement due to fraud on all audits.

How we addressed this risk

We addressed this risk by:

- reviewing the key areas within the financial statements where management has used judgement and estimation techniques and considering whether there is evidence of unfair bias;
- examining any accounting policies that vary from the Government Financial Reporting Manual;
- testing the appropriateness of journal entries recorded in the general ledger and other adjustments made in preparing the financial statements; and
- considering and testing any significant transactions outside the normal course of business or otherwise unusual.

Audit conclusion

Our work has provided the assurance we sought in each of these areas. Our testing identified a relatively small number of journals which officers had posted without a description. We have raised an internal control recommendation, see Section 5 for further details.

Significant findings (continued)

Valuation of property, plant and equipment

Description of the management judgement

LLTNPA held land and buildings with a net book value of £8.6 million as at 31 March 2023. LLTNPA's policy is to use an external Valuer to revalue its land and buildings every five years, with an interim valuation in year 3.

Valuations are based on specialist and management assumptions and changes in these can result in material changes to valuations. Due to the high degree of estimation uncertainty associated with valuations in this audit area, we have determined there is a significant risk.

How we addressed this risk

We addressed this risk by:

- assessing the scope and terms of engagement with the Valuer;
- assessing the competence, skills and objectivity of the Valuer;
- assessing how management use the Valuer's report to value land and buildings included in the financial statements;
- testing the accuracy of the data used in valuations;
- challenging LLTNPA and Valuer's assumptions and judgements applied in the valuations;
- reviewing the valuation methodology used, including the appropriateness of the valuation basis; and
- considering the reasonableness of the valuation by comparing the valuation output with market intelligence.

Audit conclusion

Our work has provided the assurance we sought in each of these areas and has not highlighted any material issues to bring to your attention.

Significant findings (continued)

Valuation of the net defined benefit liability/surplus

Description of the risk

LLTNPA had a net pension asset of £2.9 million at 31 March 2023. Estimation of the net pension asset or liability depends on several complex judgements which are sensitive to changes. These include the discount rate used, the rate at which salaries are predicted to increase, inflation rates and life expectancy. The 2023/24 pension liability/surplus was based on the results of the latest triennial pension fund valuation. Due to the high degree of estimation uncertainty associated with the valuations, we have determined there is a significant risk in this area.

How we addressed this risk

We addressed this risk by reviewing the controls that LLTNPA has in place over the information sent to the Scheme Actuary by the fund administrators (Strathclyde Pension Fund).

We also:

- assessed the skill, competence and experience of the Fund's actuary;
- challenged the reasonableness of the assumptions used by the actuary as part of the annual IAS 19 valuation, including on asset ceiling calculations if required;
- carried out a range of substantive procedures on relevant information and cash flows used by the actuary as part of the annual IAS 19 valuation, including membership data testing.

Audit conclusion

At the time of reporting, we have not received the assurances sought from the Strathclyde Pension Fund external auditors. This means our procedures in this area are ongoing.

Enhanced Risk/Key areas of management judgement

Expenditure recognition	Description of the risk
	<p>Practice Note 10: Audit of financial statements and regularity of public sector bodies in the United Kingdom highlights that, as most public-sector bodies are net spending bodies, the risk of fraud related to expenditure may be greater than the risk relating to revenue recognition.</p> <p>A significant amount of LLTNPA's expenditure is salaried staff costs, depreciation and impairment. Staff costs are well controlled and made up of low value individual transactions. Depreciation and impairment are funded by agreed forecast Scottish Government funding and there is therefore less incentive to manipulate. Revenue recognition**Description of the risk**

As set out in International Standard on Auditing (UK) 240: The auditor’s responsibilities relating to fraud in an audit of financial statement, there is a presumed risk of fraud over the recognition of revenue. There is a risk that revenue may be misstated resulting in a material misstatement in the financial statements.

LLTNPA has material programme and project income. The nature of this income means there is an increased risk that it is incorrectly recognised.

How we addressed this risk

We addressed this risk by undertaking substantive procedures to ensure programme and project income is recorded appropriately in the financial statements.

Audit conclusion

Our work has provided the assurance we sought in each of these areas and has not highlighted any material issues to bring to your attention.

Significant findings (continued)

Qualitative aspects of LLTNPA's accounting practices

We have reviewed LLTNPA's accounting policies and disclosures and concluded they comply with the Government Financial Reporting Manual (FReM) 2023/24, appropriately tailored to LLTNPA's circumstances.

We agreed at the planning stage of the audit that officers would provide the unaudited annual report and accounts on 10 June 2024. We received unaudited annual report and accounts on 17 June 2024, however these were incomplete. We received a substantially complete set of annual report and accounts on 24 June 2024.

Significant matters discussed with management

During our audit we communicated the following significant matters to management:

Valuation of Property, Plant and Equipment. LLTNPA did not undertake a full valuation of property, plant and equipment, which is in accordance with its accounting policy for valuation of property, plant and equipment. Therefore, for the year ended 31 March 2024, it applied a flat indexation rate of 3.3% to the land and buildings valued on a depreciated replacement costs basis and updated asset values in line with the results of this exercise. This involved the input of its valuers, Ryden LLP. This approach to assets valuation taken during the year 2023/24 was planned by the LLTNPA and in line with their accounting policy for valuations.

We challenged the approach taken by management through:

- reviewing the valuation methodology used, including the appropriateness of the valuation basis; and
- considering the reasonableness of the valuation by comparing the valuation output with market intelligence.

At the time of this report, we have no issues to report regarding the valuation of property, plant and equipment.

Significant difficulties during the audit

As noted above we received the unaudited annual report and accounts later than planned. This contributed to delays in completion of some of our audit work.

Significant findings (continued)

Wider responsibilities – statutory reporting

We are required to notify the Auditor General when circumstances indicate that a statutory report may be required.

- Section 22 of the Public Finance and Accountability (Scotland) Act 2000 allows us to prepare a report to bring to the attention of the Scottish Parliament and the public, matters of public interest arising during the audit of LLTNPA.

We confirm no such reports have been prepared.

- Section 23 of the Public Finance and Accountability (Scotland) Act 2000 allows us to initiate an examination into the economy, efficiency and effectiveness with which LLTNPA and their officeholders have used their resources in discharging their functions.

We confirm that no such examinations have been initiated.

Internal control conclusions

Internal control conclusions

Overview of engagement

As part of our audit, we obtained an understanding of LLTNPA's internal control environment and control activities relevant to the preparation of the financial statements, which was sufficient to plan our audit and determine the nature, timing, and extent of our audit procedures. Although our audit was not designed to express an opinion on the effectiveness of LLTNPA's internal controls, we are required to communicate to the Audit and Risk Committee any significant deficiencies in internal controls that we identified during our audit.

Deficiencies in internal control

A deficiency in internal control exists if:

- A control is designed, implemented, or operated in such a way that it is unable to prevent, detect, and/ or correct potential misstatements in the financial statements; or
- A necessary control to prevent, detect, and/ or correct misstatements in the financial statements on a timely basis is missing.

The purpose of our audit was to express an opinion on the financial statements. As part of our audit, we have considered LLTNPA's internal controls relevant to the preparation of the financial statements to design audit procedures to allow us to express an opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of LLTNPA's internal controls or to identify any significant deficiencies in their design or operation.

The matters reported in this section of our report are limited to those deficiencies and other control recommendations that we have identified during our normal audit procedures and which we consider to be of sufficient importance to merit being reported.

If we had performed more extensive procedures on internal control, we might have identified more deficiencies to report or concluded that some of the reported deficiencies need not in fact have been reported.

Our comments in this section should not be regarded as a comprehensive record of all deficiencies that may exist or improvements that could be made.

The deficiencies in LLTNPA's internal controls that we have identified as at the date of this report are in set out on the following pages.

Significant deficiencies in internal control

A significant deficiency in internal control is one which, in our professional judgement, has the potential for financial loss, damage to reputation, or a loss of information which may have implications on the achievement of business strategic objectives. Our view is that observations categorised as a significant deficiency is of sufficient importance to merit the attention of the Audit and Risk Committee.

We have not identified any significant deficiencies in LLTNPA's internal controls as at the date of this report.

Other observations

We also record our observations on LLTNPA's internal controls where, in our professional judgement, there is a need to strengthen internal control or enhance business efficiency that do not constitute significant deficiencies in internal control but which we view as being important for consideration by management.

Internal control conclusions (continued)

Other deficiencies in internal control

In our view, there is a need to address the deficiencies in internal control set out in this section (which are not deemed to be significant deficiencies) to strengthen internal control or enhance business efficiency. Our recommendations should be actioned by management in the near future.

Description of deficiency

Information and Data Security – Level 3

LLTNPA has not obtained Cyber Essentials Plus accreditation. Cyber Essentials is a Government backed scheme designed to help protect organisations against a range of the most common cyber attacks. Cyber Essentials Plus includes a hands-on technical verification. LLTNPA is working to address the recommendations of the review, however it is unlikely to be able to address these in time to achieve accreditation this year.

Potential effects

LLTNPA may be exposed to attempts to harm or exploit its computer systems.

Recommendation

LLTNPA should ensure that it addresses the findings of the assessment as soon as possible.

Management response

LLTNPA failed based on one remediation; an outdated version of Python software required to run software required for our planning function. Given possible solutions, we would not be able to address this in time to retain our CE+ accreditation. The out-of-date software will be remediated by the end of financial year 24/25 when our eplanning environment will be migrated to the software vendors hosted environment, and the related software updated to remove the vulnerability. As we passed all other points related to the CE+ audit, we are comfortable we have protection in place to mitigate accessing this vulnerability. We will re-test for CE+ once this migration has completed.

It should be noted that we did pass our CE self accreditation.

Internal control conclusions (continued)

Description of deficiency

Journals with no description

As part of our testing to address the risk of management override of controls, we obtained LLTNPA's complete ledger and analysed the manual entries using our data analytics software. This included extracting any journal entries which did not have a description. We found 16 instances of journals posted without a description. This is a small proportion of the 31,457 journals processed during the year, however we identify this as a characteristic of a high-risk journal as having no description makes it very difficult to identify what the journal relates to and its appropriateness. Following further investigation, officers provided reasonable explanations for why these journals had been posted.

Potential effects

Descriptions on journal entries assist in understanding the nature of the entry and whether it is appropriate. The absence of descriptions increases the risk of fraud or error in LLTNPA's financial records.

Recommendation

Management should ensure all journal entries include a suitable description for why the entry has been made.

Commentary on Wider Scope

Wider scope summary

As auditors appointed by the Auditor General for Scotland, our wider scope responsibilities are set out in the Code of Audit Practice 2021. The Code requirements broaden the scope of the 2023/24 audit and allow us to use a risk-based approach to report on our consideration of LLTNPA's performance and make recommendations for improvement and, where appropriate, conclude on LLTNPA's performance.

The Code's wider scope framework is categorised into four areas:

- financial management;
- financial sustainability;
- vision, leadership and governance; and
- use of resources to improve outcomes.

The Code of Audit Practice allows an alternative audit approach where an audited body is considered less complex due its size and limited financial activity. In the Annual Audit Plan, we documented our judgement that LLTNPA is a less complex body. We have reviewed this assessment and confirmed that it remains appropriate. We therefore restricted our wider scope work to:

- a review of the Governance Statement
- concluding on the financial sustainability of LLTNPA and the services that it delivers in the medium to longer term.

Best Value

Best Value in central government bodies

The Scottish Public Finance Manual (SPFM) explains that accountable officers have a specific responsibility to ensure that arrangements have been made to meet their Best Value obligations. The duty of Best Value as set out in the SPFM is:

- To make arrangements to secure continuous improvement in performance whilst maintaining an appropriate balance between quality and cost; and, in making those arrangements and securing that balance; and
- To have regard to economy, efficiency, effectiveness, the equal opportunities requirements and to contribute to the achievement of sustainable development.

Ministerial guidance for Accountable Officers in public bodies sets out their duty to ensure that arrangements are in place to secure Best Value in public services.

The seven Best Value characteristics have been recently regrouped to reflect the key themes which will support the development of an effective organisational context from which public services can deliver key outcomes and ultimately achieve Best Value:

1. Vision and leadership
2. Governance and accountability

7. Fairness and equality

We have used a risk-based approach that is proportionate to the size and type of the body, to assess whether LLTNPA has made proper arrangements for securing Best Value. We have also followed up on previously reported Best Value findings, where applicable, and have assessed the pace and depth of improvement implemented by LLTNPA.

Best Value

Best Value in central government bodies – continued

LLTNPA prepares an annual report on Best Value to demonstrate its compliance with Best Value guidance for Accountable Officers, issued by the Scottish Government. Officers presented the latest Best Value report to the Audit and Risk Committee in June 2024. This sets out LLTNPA's achievements against each of the Best Value themes. LLTNPA could better demonstrate the effectiveness of its Best Value arrangements by carrying out a formal assessment of its compliance with the Best Value themes, for example through a self-assessment.

LLTNPA has identified its annual operational plan as its main monitoring tool for assessing continuous improvement. The annual operational plan is aligned to the objectives in the National Park Partnership Plan.

Overall, we have concluded that LLTNPA has reasonable arrangements in place to secure Best Value. The new corporate plan, which is due to be finalised in December 2024, will provide LLTNPA and auditors with a framework to measure its pace and depth of improvement going forward. As noted above, there are opportunities for LLTNPA to strengthen its annual Best Value review.



In addition, we have assessed the adequacy of LLTNPA’s arrangements for preventing and detecting fraud or other irregularities as part of the wider scope audit and concluded that they are sufficiently designed and implemented.</p> <p>We will obtain written representations from management, and where appropriate Those Charged With Governance, confirming that:</p> <ul style="list-style-type: none"> a) they acknowledge their responsibility for the design, implementation and maintenance of internal control to prevent and detect fraud; b) they have disclosed to the auditor the results of management’s assessment of the risk that the financial statements may be materially misstated as a result of fraud; c) they have disclosed to the auditor their knowledge of fraud or suspected fraud affecting the entity involving: <ul style="list-style-type: none"> i. Management; ii. Employees who have significant roles in internal control; or iii. Others where the fraud could have a material effect on the financial statements; and d) they have disclosed to the auditor their knowledge of any allegations of fraud, or suspected fraud, affecting the entity’s financial statements communicated by employees, former employees, analysts, regulators or others.

Appendix E: Wider scope ratings

We need to gather sufficient evidence to support our commentary on LLTNPA's arrangements and to identify and report on any risks. We will carry out more detailed work where we identify significant risks. Where significant risks are identified we will report these to LLTNPA and make recommendations for improvement. In addition to local risks, we consider challenges that are impacting the public sector as a whole.

We have assigned priority rankings to each of the risks identified to reflect the importance that we consider each poses to your organisation and, hence, our recommendation in terms of the urgency of required action. The table below describes the meaning behind each rating that we have awarded to each wider scope area based on the work we have performed.

Rating	Description
Level 1	The identified risk and/or significant deficiency is critical to the business processes or the achievement of business strategic objectives. There is potential for financial loss, damage to reputation or loss of information. The recommendation should be taken into consideration by management immediately.
Level 2	The identified risk and/or significant deficiency may impact on individual objectives or business processes. The audited body should implement the recommendation to strengthen internal controls or enhance business efficiency. The recommendations should be actioned in the near future.
Level 3	The identified risk and/or significant deficiency is an area for improvement or less significant. In our view, the audited body should action the recommendation, but management do not need to prioritise.
