REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

Thank you for your information access request, which we received by email on 25 September 2024 and have processed under the Freedom of Information (Scotland) Act 2002. Our response is provided below.

Your Request

I was unable to attend the public meeting [of LLTNPA's Board on 16 September 2024] and was unable to view the live feed that was recorded at the time. As this was a public meeting I see no reason why it can no longer be viewed. Can you advise how to get access.

Our Response

Under section 17(1) of the Freedom of Information (Scotland) Act 2002, a public authority is required to notify the applicant if the information they have requested is not held. I can confirm that the National Park Authority does not hold the information you have requested in this instance. Specifically, we do not hold a recording of the board meeting that took place on 16 September 2024.

The 16 September 2024 board meeting was held in public and broadcast live over the internet. Furthermore, to accommodate the attendance of as many people as possible, the venue of the meeting was changed, from the National Park Authority's headquarters on Carrochan Road, to Lomond Parish Church. While this relocation allowed for greater attendance at the meeting, it meant that the National Park Authority had to employ the services of an external company to ensure the event could be broadcast live. As a result, the National Park Authority does not hold a recording of the meeting.
