Thank you for your email of 17 March 2025 in which you requested access to information you believe may be held by the National Park Authority. We have processed your request under the Freedom of Information (Scotland) Act 2002 and our response is provided below.

Your Request

1. A breakdown of the number of Loch Lomond and The Trossachs National Park Authority employees grouped by salary bands (e.g., £50,000–£55,000, £55,001–£60,000, etc.).
2. The number of Loch Lomond and The Trossachs National Park Authority employees whose annual salary is £50,000 or higher.
3. The number of Loch Lomond and The Trossachs National Park Authority employees whose annual salary is £80,000 or higher.
4. The number of Loch Lomond and The Trossachs National Park Authority employees whose annual salary is £100,000 or higher."

Our Response

1. Please see the below table which details the number of staff that the National Park Authority employs at each of its salary bands (as of 03 April 2025). Please note that, due to the small number of staff employed at bands F and above, we have simply confirmed that between 1 and 5 members of staff fall within each of these bands. We have done this in order to protect the personal information of our staff, in line with the
