REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

We refer to your request for information, received by email on 23rd June 2025. The information you have requested is environmental information, as defined in Regulation 2 of the Environmental Information (Scotland) Regulations 2004 (EIRs). We have therefore applied the exemption in section 39(2) of FOISA and dealt with your request under the EIRs alone.

Your Request:

"I would be grateful if you could provide me under Freedom of Information the following information related to the closure of the Lake of Menteith car park and also explain what action the LLTNPA intends to take to re-open it

- 1) Any information the LLTNPA holds about the closure of the car park, including any communications to and from the landowners or their agents
- 2) Any information the LLTNPA holds about its agreement with the landowners which resulted in this car park being sign posted by the National Park as being for use by the public (I have purchased the title deeds and cannot find a reference to the car park in them)

I would also request that you forward this email to the locally elected board member and councillor representative for the area and confirm you have done this."

Our Response:

The car park referred to in your request is outside the boundaries of the National Park's geographical area and therefore not part of the National Park Authority Estate. We do not have any planned actions in relation to this car park.

We advise that, in accordance with Regulation 10(4)(a) of the EIRs, we do not hold the information that you have requested.

As requested, I can confirm that a copy of your original request has been forwarded to the locally elected Board Member whose electoral ward is closest to the car park in question and both Stirling Council-nominated Members of the Board.
