REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

Thank you for your request for access to information held by the National Park Authority that we received by email on 8 August 2025. We have processed your request under the Freedom of Information (Scotland) Act 2002 and have provided our response below.

Your Request

For the time period 1st April 2024 to 31st March 2025 (or your nearest 12-month period), please provide the following:

- total number of violent incidents on your staff broken down by job title/category of worker
- a breakdown of the nature of the violent incident e.g., verbal, physical, threatening behaviour
- 3. how many violent incidents have been reported under RIDDOR (Reporting of Injuries, Diseases and Dangerous Occurrences) Regulations, with a breakdown by job title/category of worker

Please could you break this information down into incidents involving female staff / male staff.

Violent incidents can include verbal abuse or threats including face to face; online and via telephone; physical attacks; threatening behaviour; racial abuse and sexual harassment/violence.

In the year from 01 April 2024 to 31 March 2025, we logged the following number of Health and Safety Report Forms in relation to aggressive behaviour or verbal abuse. None of these incidents were deemed to be reportable under RIDDOR.
