We refer to your request for information, received by email on 29th July 2025. The information you have requested is environmental information, as defined in Regulation 2 of the Environmental Information (Scotland) Regulations 2004 (EIRs). We have therefore applied the exemption in section 39(2) of FOISA and dealt with your request under the EIRs alone.

Your Request

I would be extremely grateful if you could provide me with all information /communications which relate to EASTLANDS LTD /BALQUHIDDER BRAES HOLIDAY PARK held by Loch Lomond and the Trossachs National Trust Panning Departments, developmental services environmental health departments, health and safety department and fire safety departments. To include inspections and when they were done. This to be regardless of how it is recorded, or which format it is recorded in - and whether the Loch Lomond and Trossachs National Trust create it or have also received it by third parties.

To narrow this down. Please provide copies within last 5 years. Namely around above.

I have already received my FOI from Stirling Council, so please feel free to delete any of the above that is not relatable to the Trust and would be in the interest of Stirling Council, as I already have my reply back on the FOI I sent Stirling Council.

Thank you for your submission.

Unfortunately, the form you completed was for a Non-Material Variation (NMV), which is not suitable in this case. A Section 42 application requires a full planning application, to be submitted via the ePlanning portal.

What to do:

- Use the same application form as a planning permission on eplanning Scotland
- Under "Type of application" on the application form tick the box against 'Further application'
- You'll need to reference the original permission: 2021/0337/DET, decision issued on 25.01.2022.

Suggested description for the proposal:

 Further application (under Section 42) to vary Condition 2 of previous planning permission (2021/0337/DET) to allow 4 of the 14 caravans to be used as staff accommodation.

The fees for this application are as follows

Fees are now paid directly via Gov.UK Pay through the ePlanning portal.

^{*}Advert fee explanation: As part of processing planning applications, the National Park Authority has to notify neighbours within 20m of the application site. Where there is land that has no property for the notice to be sent to, we are required to advertise the application in the local press. The applicant is required to pay the cost of this advert. The cost of this advert is £160.

I've copied in our Planning Support team to confirm whether the £238 already paid can be refunded or transferred. Since a new planning reference will be generated for the Section 42 application, a transfer may not be straightforward—I'll update you once I hear back.

As this is a full planning application, please ensure you include all the necessary documents and plans for the application to be valid. You may wish to refer to the HOPS validation guidance: https://hopscotland.org.uk/guidance-documents/

In this case, you'll likely need:

- Correctly completed application form (not application type is for 'further application')
- signed land ownership certificate (part of the application form)
- Location plan (and possibly supplementary location plan) reuse of plans used in the previous submission in this instance is fine so long as there's no "approved" watermark.
- Photos of the caravans proposed for staff use and surrounds.
- A supporting statement that clearly outlines how the business will be managed i.e. staff numbers, accommodation and location of any office/reception on site

I'll follow up shortly regarding the fee issue.
