## **REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002**

We refer to your request for information, received by email on 13 October 2025. The information you have requested is environmental information, as defined in Regulation 2 of the Environmental Information (Scotland) Regulations 2004 (EIRs). We have therefore applied the exemption in section 39(2) of FOISA and dealt with your request under the EIRs alone.

### **Your Requests**

I would be grateful if you would forward on a copy of the applicant's proposal to extract water from a burn-fed supply together with their plan to keep the requisite proposed infrastructure wholly within the curtilage of their property.

We would like to see the evidence that the burn will provide sufficient water even under drought conditions as required by Stirling Council's Environment Health department.

We would also like to see the approval from Stirling Council's Environmental Health department.
