## Notice of Election

**9 July 2026**

NOTICE IS HEREBY GIVEN that elections to elect one Member to The Loch Lomond and The Trossachs National Park Authority to represent each of the undernoted wards within the National Park Area will be held on 9 July 2026, in accordance with The Loch Lomond and The Trossachs National Park Elections (Scotland) Order 2002.

Anyone who wishes to clarify their entitlement to vote should contact their local Electoral Registration Officer. Applications to register to vote, or change their registered details, must reach the relevant Electoral Registration Officer by 12 midnight on **Thursday 4 June 2026**. Applications can be made online: <https://www.gov.uk/register-to-vote>.

Any eligible elector can apply to the Electoral Registration Officer to have his/her ballot paper sent to an address other than that appearing on the electoral register. To do this they need to request an application form from the Electoral Registration Officer by emailing [registration@centralscotland-vjb.gov.uk](mailto:registration@centralscotland-vjb.gov.uk) or telephoning (01786) 892289. All forms must be duly completed and returned to the Electoral Registration Officer, Ground Floor Right, Glendevon House, The Castle Business Park, Stirling, FK9 4TZ no later than 5pm on Thursday 4 June 2026.

Anyone wishing to be a candidate at these elections should obtain a nomination paper from the office dealing with the ward for which they wish to stand as detailed below. All forms must be duly completed and returned by hand to the Stirling Council Election Office, Room 56, Old Viewforth, Stirling, FK8 2ET **no later than 4pm on Thursday 4 June 2026**.

To qualify, candidates must be over 21 years of age, but need not be resident in the Ward for which they wish to stand, nor the Park area generally. A nomination paper must, however, be subscribed by 2 electors as proposer and seconder and by 8 other electors living in that electoral Ward as assenting to the nomination.

In the event of a poll, ballot papers will be issued to all eligible electors by first class mail between 11 and 15 June 2026, and must be returned by **4pm on Thursday 9 July 2026**, if they are to be included in the counting of votes.
