## **REQUEST UNDER FREEDOM OF INFORMATION (SCOTLAND) ACT 2002**

We refer to your request for information, received by email on 24 March 2026. Your specific requests and the Park Authority's response are provided below.

### **Your Requests**

I am looking to understand what engagement and discussion with the LLTNPA Board has taken place about the review of the camping byelaws (outside of public board meetings). Please provide me, under Freedom of Information, law with:

- 1) The dates and agendas of any briefing/discussion sessions involving the main board or any sub-groups of board members where the review of the camping byelaws was discussed
- 2) Any information about the review presented at those meetings (eg powerpoint presentations, discussion papers etc) or circulated to board members before or after
- 3) Any record/minute of those meetings

### **Our Responses**

During a strategy session which took place after the Board meeting on 15 September 2025, there was a presentation given on the Camping Management Byelaw Review. I have attached a copy of the presentation slides. Please note that the data within the board presentation slides was under development and presented for discussion. Camping Management data continues to be interrogated and refined.

In February and March this year, there were planned workshops that took place online and in Balloch and Callander to discuss the Review. An email was distributed inviting key stakeholders, communities, landowners, businesses or agency partners with a discussion pack. I have attached a copy of this discussion pack.
